## 1. Review of matters from previous minutes.

a. Pool Closing 9/26/16. Need to inform all homeowners.

b. Picnic tables (2) will be posted for sale for \$30 each (As is), after our fall events. Saving the new tables purchased for next spring, will set up by the Annual Meeting.

c. Sarah Reed picked up the following items from the Horne's residence. Dormer for playground (Damaged, will try to repair), lumber- 2"x4"x8' (qty. 3), and 1 pint of paint.

d. New security system installed and tutorial took place on operation with Parks Communication and all board members in attendance. Final payment needs to be sent to Parks Communication.

e. Discussed the annual lawn care contract that we have with Jon Hilton. He is interested in renewing at the same rate of \$225/month. The trimming of the bushes and weeding was also discussed. Jon stated that he does those twice a year. The board plans to get estimates from two other companies for review. Discussed replacing the timbers around the playground and pool. Jon Hilton will provide estimate for review.

f. Resurfacing the pool will be discussed at the next meeting.

## 2. Reports from Committees

- a. Architectural Committee had a meeting on Sept 7th
- b. Social Committee

i. Movie Night – MJM Entertainment for \$250 plus approx. \$50 for supplies. Will be BYOD, chairs/blankets to start at dusk. We can pick movie and need to provide. Discussed hosting on either Oct. 8<sup>th</sup> or Oct. 15<sup>th</sup>. Since meeting, MJM did not have proposed dates available. Movie Night has been cancelled for now and focus put solely on Fall Festival.

- ii. Fall Festival Saturday, November 5<sup>th</sup> 4-7pm (welcome to stay later and visit with your neighbors!) Budget is approx. \$600. WPHA will supply hot dogs, hamburgers and water, as well as plates/silverware. Homeowners will be asked to bring either appetizers or desserts, determined by house number odds/evens. There will be games, crafts and a bounce house and like years past we will have a Halloween costume contest.
- iii. Santa's Visit. Cost is \$300. Committee will be asking homeowners for a volunteer to host this year, otherwise we may not be able to have.
- c. Sunshine Committee
  - i. Sarah has 3 deliveries to make this week. 2 recent new homeowners and a new baby.
- d. Neighborhood Watch
  - i. Nick attempted to meet with Sheriff in charge of the "Neighborhood Watch", but Sheriff was unavailable and meeting was rescheduled.
  - ii. Discussed concerns of homeowners about speeding, once again we would have to have 90% of the WP homeowners to sign a petition to make any changes; add speed bump, stop signs, etc.

- b. Being tabled until next meeting, but we discussed looking into a termite service.
- c. Also discussed but up for review at next meeting, PayPal option for Dues payments.
