Wildcat B Boundaries, Name Change

The boundaries of all our various representative districts have changed in some way as a result of the 2000 census. However, Waverly Park (WP) "moved" only in the congressional district.

WP residents have voted in Wildcat B precinct at Holly Springs Elementary School on Hickory



Road. WP will continue to vote at Holly Springs Elementary but the precinct will be renamed "Wildcat." The county voter registrar will mail new precinct cards reflecting the changes.

The county commission and board of education district changes and the precinct realignments must still be approved by the U. S. Justice Department. The federal and

Regular Meeting, 6:00 p. m. 4/21/02, WP Pool

- Approved amended minutes of 4/4/02 members' meeting

- Directed Treasurer to send final letters to three homeowners with delinquent assessments and interest: "Pay by May 31 or liens filed."
- Discussed a 30/60/90-day (interest/lien/foreclosure) timetable for handling delinquent assessments. Consult with lawyer.
- Agreed to special directors' meeting week of April 29 with contractor to decide barriers to protect newly repaired walking trail from unauthorized vehicles
- Agreed to pool opening date of May 3
- Agreed to pay Emily Isenberg \$150 per month to cut common area grass, minimum of twice a month.
- Agreed to pay \$40 per month for twice-a-week restroom cleaning; check-list to be developed
- Agreed to let Treasurer research and change bank

Annual Members Meeting Notes

The homeowners' annual meeting was held at 7:30 p. m., April 4 as scheduled. Twenty homeowners were represented in person or by proxy.

The Board presented a Statement of Corporate Affairs and a financial statement.

Discussion was held concerning the completion of walking trail repairs, the pool opening and election of new officers.

The walking trail repairs were originally estimated from three to five thousand dollars at the last annual homeowners meeting but came in at twenty eight hundred. The members feel that some sort of protection from four-wheelers might be appropriate.

The pool opening is scheduled for May 3 to be preceded by a county inspection on April 23 and a cleanup on April 20. The clean-up runs from 10-2 p. m. to take care of gutters, pressure washing, clock, phone, etc.

The new board of directors confirmed by the membership are Cyndi Chandler, Carol Knapp, Hamp Reid and Greg Vence. The board will meet to determine officers (See **WPHA Board of Directors**, page 2.)

Architectural Committee Update

If you plan to add a structure, change the exterior of your home or

lot, or the use of your lot, you must submit plans to the Architectural Committee (AC) for approval.

Plans must include dimensions of the project, its location on the lot and materials and colors to be used. A letter explaining your plans is needed. The covenants give the

AC up to 60 days to review plans; however, reviews are currently taking about two weeks from the time the AC receives useable plans. De-

cisions require a majority vote of the AC.

Please give your plans to Hamp at 613 Ashley Trail.

In addition to AC approval, projects should comply with any applicable county ordinances and zoning

regulations and may require county permits.

 Ilona Sanders, (R-Sutallee).
 Post 4 is also in the Western
 District and both commissioners are elected by all voters in the Western District.
- Cherokee County Board of Education. There are seven

posts on the board. All board members run countywide.

Primary elections are August 20, 2002, followed by the general election on November 5.
