The 2003 annual assessment bills were mailed to Waverly Park homeowners on January 16.

This year's assessment is \$144.70 and payment is due on or before February 28.

The Board of Directors fixed the amount of the 2003 assessment at their meeting on October 27, 2002. An article in the November *Waverly Park Press* announced the increase.

Waverly Park's covenants set remedies for the Association for unpaid assessments. Board

Resolution 7 adopted a timeline for implementing those remedies that include, voting rights suspension, interest, property lien and foreclosure.

## **County Rezoning Notification Changes**

During their final 2002 meeting, the Cherokee County Board of Commissioners approved new notification requirements for rezoning applications.

Developers are now required to notify all property owners within 750 feet of a proposed devel-

opment. Previously, only adjacent property owners were notified.

Additionally, homeowners associations representing property owners in the 750-foot radius can register with the county planning office to be notified. WPHA registered

with the county on January 31.

Developers are now required to hold community meetings with local residents to discuss a project before the project can be submitted to the planning commission.

### **Animals Creating Nuisance**

From Cherokee County Code of Ordinances, Sec. 10-65.

"(a) The owner of any animal which habitually barks, whines, howls or causes other objectionable noise, or which is at large or chases or runs after persons or vehicles, or which destroys or damages any property of another person, or which causes serious annoyance to a neighboring resident and interferes with reasonable use and enjoyment of his property, or which is otherwise offensive so as to create a nuisance, shall be deemed to be committing an act in violation of this section.

(b) Any resident of the county or a city in the county living or residing in the vicinity in which the violation and issue occurred may report the violation, stating the date and the nature of the act, the name of the owner of the animal, the address of the owner of the animal and a description of the animal doing such act. The animal control officer may require such information to be in writing and signed and sworn to before acting on it. The animal control officer shall investigate the complaint and determine whether the act complained of violated this article. If a determination is made in the affirmative, he

shall proceed to pursue such remedies as provided for under this article and state law."

### **Outdoor Watering Restrictions End for Now**

The Georgia Environmental Protection Division (EPD) ended the drought-related restriction on outdoor watering on January 15.

Local governments still have the option of imposing their own water use restrictions, but the county is following the state's lead and has lifted all county watering restrictions. The Cherokee County Water Authority website indicates that there are no current watering bans.

#### **Drought versus Conservation**

The drought-related restrictions



may be gone, but look for the state to impose some kind of watering restrictions in the name of conservation.

The EPD has nearly completed a plan to manage water use based on conservation, rather than on drought. This plan will define some level of outdoor water use restrictions to be followed by all Georgians during non-drought periods.

### **Architectural Committee Update**

If you plan to add a structure, change the exterior of your home or lot, or the use of your lot, you must submit plans to the Architectural Committee (AC)

for approval.

Plans must include dimensions of the project, its location on the lot and materials and colors to be used. A letter explaining your plans is needed. The covenants give the AC up to 60 days to review plans; however, reviews are currently taking about two weeks from the time the AC

receives useable plans. Decisions require a majority vote of the AC.

Please give your plans to Hamp at 613 Ashley Trail.

In addition to AC approval, projects

should comply with any applicable county ordinances and zoning regulations and may require county permits.
