Register To Vote In 2004

-From Georgia Secretary of State Website

If you are not registered to vote, it is not too early to consider it. 2004 will be a busy election year. Offices to be filled include:

- President of the United States
- 1 U.S. Senate seat (seat currently held by Zell Miller)
- 13 U.S. Representative seats
- 1 Public Service Commission seat
- Judicial offices
- State Senators (all seats)
- State Representatives (all seats)

All local two-year officials.

Voter registration deadlines and election dates are shown in the table on page 4.

Georgia citizens have access to several convenient methods of registering to vote:

- Contact Cherokee County Voter Registrar at 770-479-0407.
- E-mail a request for a voter registration form to the Georgia Secretary of State at sosweb@sos.state.ga.us,
- Motor Voter registration is offered when you renew or apply for your driver's license at Department of Motor Vehicle Safety drivers license posts.

 College students can obtain Georgia voter registration forms, or the necessary forms to register in any state from their school registrar's office or Academic Affairs office.

In the past, Commissioners meetings were broadcast live on Adelphia Cable and later only on a taped basis.

Adelphia dropped the meetings altogether earlier this year.

Architectural Committee Update

If you plan to add a structure including a fence, change the exterior of your home or lot, or the use of your lot, you must

submit plans to the Architectural Committee (AC) for approval.

Plans must include dimensions of the project, its location on the lot and materials and colors to be used. A letter explaining your plans is needed.

See the Architectural Guide available on the website for more information.

The covenants give the AC up

to 60 days to review plans; however, reviews are currently taking about two weeks from the time the AC receives useable plans. Decisions require a majority vote of the AC. Please give your plans to Hamp at 613 Ashley Trail.

In addition to AC approval, projects should comply with any applicable county ordinances and zoning regulations and may require county permits.

Reminder

Covenant restrictions will be uniformly enforced beginning on January 1, 2004 for:

- Trash can storage
- Approved vehicle parking spaces
- Commercial vehicles

County Noise Ordinance Clarified

The Cherokee County Board of Commissioners approved a revision of the county's antinoise ordinance at their November 18 meeting.

The times in the ordinance were clarified by adding "a.m." and "midnight" after each reference to 12.

Apparently, some people were confused as to which 12 o'clock was being referred to in the ordinance --- the one in the middle of the day or the one in the middle of the night.

Section 26-39(a) Revised Prohibited Noise Ordinance

"It shall be unlawful for any person to willfully make, continue or cause to be made or continued excessive, unnecessary or unusually loud noise which disturbs the peace or quiet of any neighborhood, or which causes discomfort or annoyance to any reasonable person of normal sensitiveness residing within the limits of the County, between the hours of 12:00 a.m. (midnight) and 7:00 a.m. daily, and between the hours of 12:00 a.m. (midnight) Saturday night and 1:00 p.m. Sunday. Also, all such noises described in this section shall be unlawful after 6:30 p.m. Sunday until 7:00 a.m. Monday."
