Pool Use Reminders

Here are a few reminders about some of the rules intended to promote the safe use of the WP pool.

- Children under 14 must be accompanied at all times by an adult 18 years or older.
- Pool hours are daily 7:00 a.m. to 10:00 p.m.
- Non-residents found in the pool area should be asked

to leave by any resident and could be prosecuted for trespassing.

- Authorized guests must be accompanied at all times by their WP sponsor. See Common Area Rules in Board Resolution 3 on the WPHA web documents page for more information about guests.
- All residents need to be involved in keeping up with the pool and who is using it. If someone comes



to the gate without a key and you don't know them-ask!

- Last one leaving the pool area please check that all lights and fans, including the pool light, are turned off. This will help keep the bugs and frogs from having a pool party.
- Thanks and have a nice swim.

All Consumer Fireworks Are Illegal In Georgia

—From Georgia Safety Fire Commissioner up to one year in jail.

"The sale and use of any type of fireworks, including firecrackers, cherry bombs and sparklers, are illegal in Georgia and punishable by a maximum fine of up to \$1,000 and a sentence of Don't risk injury to yourself or your family -- please enjoy your Fourth of July by viewing fireworks at a professional show handled by licensed experts."



Architectural Committee Update

If you plan to add a structure including a fence, change the exterior of your home or lot, or the use of your lot, you must submit plans to the Architectural Committee (AC) for approval.

Plans must include dimensions of the project, its location on the lot and materials and colors to be used. A letter explaining your plans is needed.

See the Architectural Guide, available on the website, for more information.

The covenants give the AC up to 60

days to review plans; however, reviews are currently taking about two weeks from the time the AC receives useable plans. Decisions require a majority vote of the AC.

Please give your plans to Hamp at 613 Ashley Trail or e-mail them to the address in the box at left.

In addition to AC approval, projects should comply with any applicable county ordinances and zoning regulations and may require county permits.

Election Year Continues July 20

A busy 2004 election year that began in March continues with the July 20 general primary and ends on November 2 when the U. S. elects a president.

On July 20, voters will be offered one of three ballots:

- Democratic (including Non-Partisan)
- Republican (including Non-Partisan)
- Non-Partisan

Since there are no Democrat candidates for county and state positions representing Waverly Park (WP), if you choose the Democratic ballot you will vote only for Democratic candidates running for two offices: U. S. Senate and state Public Service Commissioner.

The Republican ballot has Republican

candidates for the same U. S. Senate and state Public Service Commissioner seats. But it also includes candidates that will represent WP in the state senate and house, and on the county board of commissioners. There are contested races for chief magistrate and clerk of superior court.

Many other positions are uncontested and the ballot lists only the incumbent.

Non-partisan candidates are state supreme court justices, state appeals court, state court and superior court judges. These candidates are included in separate non-partisan sections on both the Democratic and Republican ballots.

However, if you choose the Non-Partisan ballot you will be able to vote only for the justices and judges. View sample ballots at:
