

## Architectural Committee Update

If you plan to add a structure including a fence, change the exterior of your home or lot, or the use of your lot, you

must submit plans to the Architectural Committee (AC) for approval.

Plans must include dimensions of the project, its location on the lot and materials and colors to be used. A letter explaining your plans is needed.

See the Architectural Guide, available on the website, for more information.

The covenants give the AC up to 60 days to review plans; however, reviews are currently taking about two weeks

## Outdoor Burning OK With Permit

The annual residential outdoor burning ban in Metro-Atlanta counties ended yesterday. The Georgia Forestry Commission now handles burn permits for Cherokee County. Permits, good for day of issue, and burning requirements are available online from the Georgia Forestry Commission at:

The annual burning ban is May 1 – September 30 of each year.

## What Is A Government House Anyway?

We've all seen the signs for one of WP's homes on Westchester Way. But just what is a HUD house— a government house? By the way, HUD is short for the U.S. Department of Housing and Urban Development.

Occasionally, a lender is forced to foreclose on a FHA-insured home. The lender files a claim to have HUD pay the balance due on the mortgage and assume ownership of the foreclosed property. These properties then become

#### HUD homes.

Normally, HUD homes are sold in an "Offer Period." Interested persons submit bids to HUD through a participating real estate agent. At the end of the Offer Period, all offers are opened and the highest reasonable bid is accepted. If the home isn't sold in the initial Offer Period, bids are accepted until the house sells.

HUD homes are sold "as-is," without warranty. That means that HUD will not pay to correct any problems. If necessary, HUD's asking price on the home will reflect the fact that the buyer will have to invest money to make improvements. HUD might offer special incentives such as an allowance to upgrade the property, a moving expense allowance, or a bonus for closing the sale early.

The buyer can request HUD to pay all or a portion of the financing and closing costs.
