General Election Is Tomorrow

Waverly Park residents who go to the polls tomorrow will vote on candidates for federal, state and county offices, proposed constitutional amendments and county referenda.

The ballot includes contested races for:

- President of the U.S.
- · U. S. Senate
- Georgia Court of Appeals Judge
- Board of Education, Post 6

Uncontested races include:

• U. S. House

- State Senate
- State Representative
- County Commissioner, Post 3
- Board of Education
- · And others.

Georgia constitutional amendments include:

- Define marriage
- Georgia Supreme Court jurisdiction.

County referenda include:

Distilled spirits by the drink

- Alcoholic beverage Sun

Board Considers Special Assessment Vote

The Board of Directors is considering calling a special meeting of the WPHA membership for the purpose of voting on a onetime special assessment to replace the pool fence.

The special assessment would be used to partially pay to replace the deteriorating wooden fence with wrought-iron look heavy aluminum. Fence replacement estimates were in the \$7,000 to \$9,000 range and included removal of the old fence.

The issue was discussed at the board meeting on October 17. A few committee members attended and voiced opinions; however due to late minute schedule conflicts, there was not a quorum of the board present to make a final decision.

A onetime special assessment of \$50 per lot was acceptable to those present. This would raise \$4,500 to partially pay for the new fence and not bring reserves near zero.

According to our covenants, a onetime special assessment requires the approval of 2/3 of those lots represented at a meeting with a quorum of 54 lots represented in person or by proxy. Should the first meeting fail to gain a quorum, a second meeting may be called with a quorum of 27 owners. Again, 2/3 of members present must approve the assessment.

A formal meeting notice, mailed at least 30 days in advance of the meeting, is required.

must submit plans to the Architectural Committee (AC) for approval.

Plans must include dimensions of the project, its location on the lot and materials and colors to be used. A letter explaining your plans is needed.

In addition to AC approval, projects should comply with any applicable county ordinances and zoning regulations and may require county permits.
