If you plan to add a structure including a fence, change the exterior of your home or lot, or the use of your lot, you must submit plans to the Architectural Committee (AC) for approval.

Plans must include dimensions of the

project, its location on the lot and materials and colors to be used. A letter explaining your plans is needed. See the Architectural Guide, available on the website, for more in-

#### formation.

The covenants give the AC up to 60 days to review plans; however, reviews are currently taking about two weeks from the time

> the AC receives use-

able plans. Decisions require a majority vote of the AC.


