Architectural Committee Update

If you plan to add a structure including a fence, change the exterior of your home or lot, or the use of your lot, you

must submit plans to the Architectural Committee (AC) for approval.

Plans must include dimensions of the project, its location on the lot and materials and colors to be used. A letter explaining your plans is needed.

See the Architectural Guide, available

on the website, for more information.

The covenants give the AC up to 60

days to review plans; however, reviews are currently taking about two weeks from the time the AC receives useable plans. Decisions require a majority vote of the AC. Owners should not begin a project before receiving written approval from Please give your plans to Hamp at 613 Ashley Trail or e-mail them to the address in the box.

In addition to AC approval, projects should comply with any applicable county ordinances and zoning regulations and may require county permits.

pool. The damage has been minimal (the gutters were damaged and some furniture broken) but the intent was malicious.

The parking lot has become an area of questionable activities after dark and go-carts, four wheelers and motorcycles have used the trail. In the past month we have documented three times that the pool was entered by groups of young people who do not live in the neighborhood. The common

area belongs to each of us and it is important for all of us to be alert about who is there.

No one should be in the pool area unless they are a resident with a key or are a guest with the resident. We may have to install some security equipment if the problems persist but this is an expense that we hope to avoid.

Please call Pool Committee Chair Steve Dillon or one of the board members if you feel that anything improper is going on at the common area.

ALCOHOL AT POOL

Discussion: Stephen Horne received 37 votes for the straw vote regarding alcohol use at the pool. Results were 17 votes for the use of alcohol at the pool at all times, 17 votes for never using alcohol at the pool, and 3 votes for use of alcohol at certain times.

Conclusions: Board decided to allow the use of alcohol at the pool under following stipulations:

Adults using alcohol will be required to conceal in a plastic or paper cup.

Also, Please be respectful of people's beliefs and children.

Board voted 3-0 in favor of this action with one member absent.

Action items: Stephen Horne will type an amendment to Referendum 3 showing the above changes and board will vote on the amendment.

POOL VANDALISM

Discussion: We have had more vandalism at our pool. We have had people climbing and bending the bars on the fence.

Conclusions: Cherokee County Police has been notified and they have placed our neighborhood on their watch list and will have a patrol car coming through our neighborhood more often. Board discussed the possibility of setting up a neighborhood watch and/or security cameras at the pool area.

Action items: Board has asked Amanda Scott to research the use of cameras at our pool along with prices.

PICNIC

Discussion: Board discussed final preparations on the picnic set for 7/24/2005.

Action items: Have FUN!!!!

FENCE PROBLEMS

Discussion: Board feels our fence is not providing enough protection for our pool. People are bending the bars rather easily.

Conclusions: Stephen Horne is calling the fence company regarding this issue.

SECRETARY

Discussion: Although Dane Kanazawa has good intentions on being secretary, his work schedule has been keeping him very busy.

Conclusions: Board discussed finding someone to help with the secretary position of the board.

Action items: Chris Scott will be acting secretary until a replacement is found. Dane Kanazawa will still be a member of the board.

(July 24, 2005) This world would be a boring place if we all agreed on everything. We could have used a little boredom these past two weeks. In our last newsletter we asked for a vote on the use of alcohol at the neighborhood pool. Out of 90 homes we received 37 votes; only 41% of the homeowners chose to participate. Three votes were for the option of having designated hours and the remaining 34 votes were split evenly between the other two options. Handling situations like this are what we get the big bucks for as your association board of directors. :0)

We met on Thursday night July 21 to discuss the vote and try to reach a

compromise. At odds were those people who like to relax by drinking alcohol in the common area and those people who feel that their children should be able to enjoy the pool without being exposed to the consumption of alcohol. After much debate the Board reached some decisions.

DECISION 1 is RESPECT ---- We are all neighbors; we all want what is best for our community. Those who drink alcohol should have respect for the beliefs of those parents who view this in a negative light. Also consider that there might be a recovering alcoholic in the neighborhood. Just being around someone drinking can be very difficult for this person. Many of the surrounding neighborhoods have forbidden alcohol at their pools because they believe that our society has lost the art of respecting the beliefs of others. We have chosen not to take that action at this time because we believe that the people of Waverly Park still know how to have respect.

DECISION 2 is COMPROMISE----The Board has amended Resolution 3 (rules and regulations for the common area) to read as follows.

All alcoholic beverages must be in a plain cup while in the common area. At no time shall the marked container be placed on open display in a manner to be seen by other people using the common area.

Thank you to all of those who participated in the vote. We know that these decisions will not please everyone, but we do think that they are decisions we can all live with if we remember what it means to be a neighbor.
