January Board Meeting Notes

Meeting called to order by Stephen Horne at 2:00 p.m.

The minutes from the previous meeting were read and approved.

OLD BUSINESS

- Dane Kanazawa called several (15) pool companies and only three responded with quotes for pool maintenance and replastering. The board agreed to invite Steve Dillon to the next board meeting for his insight on this matter and to discuss a course of action for necessary pool repairs and maintenance.
- Discussion on the video cameras is still ongoing for the pool area and parking lot.

NEW BUSINESS

- Letters were sent out Monday January 23, 2006 for homeowners association dues for \$168.00 for each lot and will be due on or before February 28, 2006.
- Resolution 2006-01 Adopting the associations budget for the fiscal year 2006 was approved unanimously by the board of directors.

Next meeting is set for February 26, 2006

Architectural Guide Changes

This article was originally published as a WPP EXTRA.

(February 11, 2006) The WPHA Architectural Committee (AC) has adopted changes to the *Architectural Guide*.

PLANS REQUIRED on page 2 has been changed to clarify the information needed for project review and adds email as a means for homeowners to submit their project plans to the AC.

ORIGINAL ZONING RESTRICTIONS has been added on page 3 to clarify that no project will be approved that would require relaxing zoning restrictions that were in place when the current covenants were adopted. For example, a building that would encroach into a property line setback requirement would not be approved even if a zoning variance were sought from the county. The intent is to maintain neighborhood appearance.

ROOFING has been added on page 6 and clarifies that all replacement roofing must be of the same materials and color as the existing roof on a home. Since a new roof of the same materials and color will not change the exterior appearance of a home, blanket ap-

proval is given for homeowners to replace their roofs when needed without reference to the AC. This addition simply reiterates that the existing covenant restriction, found in Article V, Section 2, that existing structures shall not be altered in any way which materially changes the exterior appearance applies to replacement roofs.

The updated *Architectural Guide* is now available for download from the WPHA website Documents page. Homeowners without Internet access should contact the AC secretary if they would like an up-to-date copy.

If you plan to add a structure including a fence, change the exterior of your home or lot, or the use of your lot, you

must submit plans to the Architectural Committee (AC) for approval.

Plans must include dimensions of the project, its location on the lot and materials and colors to be used. A letter explaining your plans is needed. See the Archi-

tectural Guide, available on the website, for more information.

The covenants give the AC up to 60 days to review plans; however, reviews are currently taking about two weeks

from the time the AC receives useable plans. Decisions require a majority vote of the AC. Owners should not begin a project before receiving written approval from the AC.

Trail or email them to the address in the box.

In addition to AC approval, projects should comply with any applicable county ordinances and zoning regulations and may require county permits.
