When the picnics and the fireworks are over, don't forget what July 4 was really about — our country's independence and the right to vote.

The General Primary Election set for Tuesday, July 18 marks the beginning of this year's election cycle. Federal, State and County offices will be on our ballot. Included are Governor,

nor, U. S. Representative for the Georgia 6th Congressional District,

and the Georgia Senate and House.

County commission elections include the Chairman

and Post 4. Waverly Park is in Post 3 but votes on commissioners from the Western District, Posts 3 and 4.

Waverly Park votes at Holly Springs Elementary School on Hickory Road. The deadline for registering to vote in this primary was June 19.

### Sparklers Only Fireworks Legal In Georgia

In May 2005, Georgia lawmakers approved the sale of non-explosive fireworks, which include sparklers, snakes, glow worms and trick noise-makers. Possession and use of any other fireworks is not legal in Georgia.

don't set the woods or your neighbor's house on fire.

Or better yet, attend one of the city-sponsored fireworks displays in Woodstock or Canton.

### Hours Added To Watering Restrictions

-From Cherokee County Water Authority website

(June 22, 2006) The Cherokee County Water Authority (CCWA) has declared a Drought Response Level One. Outdoor water use may occur on scheduled days within the hours of 12:00 midnight to 10:00 a. m. and 4:00 p.m. to 12:00 midnight.

Irrigation of personal food gardens remains exempt

from the restrictions.



#### **OLD BUSINESS:**

- Work in progress for signs for street and for the pool area.
- New posts for the pavilion are being prepared and will be installed soon.
- The grass cutting committee is set and the schedule is for two people to work together and the grass will be cut every other week.
- The board discussed pool refinishing and all options are being researched, costs are being consid-

ered.

- A Board of Directors calendar of events is a work in progress and could be beneficial in the future.
- Overdue fines and assessments are being carried out according to HOA covenants and the by-laws.
- The board reviewed monthly treasurer's report and agreed by a 5-0-0 vote for on-line access to the bank account by the treasurer.
- Reimbursements to directors for expenses were made by the treasurer. Statements for expenses were reviewed and voted on by the board by a 5-0-0 vote.
- The board discussed replacing or repairing the water heater and agreed to get estimates to replace or repair it and will follow up via email.
- Replacing old and damaged pool furniture was considered and the board agreed by a 5-0-0 vote to budget \$550.00 for reclining

chairs for the pool.

 A new lock will be installed on the pump room door and keys will be duplicated and given as needed.
 The minutes for the May 9th meeting were signed as they were approved by email prior to the meeting.

The next board meeting is set for 7-11-06, at 6:00 p.m. at the pool.

Anyone with interest or concerns can observe board meetings. There is always an open forum before the meeting begins.

The meeting adjourned at 7:45 p.m.

### Architectural Committee Update

If you plan to add a structure including a fence, change the exterior of your

home or lot, or the use of your lot, you must submit plans to the Architectural Committee (AC) for approval.

Plans must include dimensions of the project, its location on the lot and materials and colors to be used. A letter explaining your plans is needed. See the Architec-

tural Guide, available on the website, for more information.

The covenants give the AC up to 60 days to review plans; however, reviews are currently taking about two weeks

from the time the AC receives useable plans. Decisions require a majority vote of the AC. Owners
