contacted the County Marshal's Office and the Department of Natural Resources and both advised me to get everyone to bring their small pets and all pet food inside. **Cherokee County does not** have the time or resources to kill or trap these animals.

Spending a lot of time in the

woods and reading up on coyotes, I can tell you they are quite common in the state of Georgia. They mainly hunt small rodents but are known for their adaptability. They can be drawn to our backyards by garbage, outdoor feedings of pets, and yes your lovely

bird feeder. They pose very little threat to humans as attacks have been on very small children and are extremely rare. Keep in mind that our

dogs pose more of a threat to humans than this coyote. Please follow the suggestion of our Marshal's Office and hopefully these animals will move along.

dents of Waverly Park. My job kept me out of the country for long periods of time. As my schedule began to change toward more domes-



Architectural Committee Update

If you plan to add a structure including a fence, change the exterior of your home or lot, or the use of your lot, you must submit plans to the Architectural Committee (AC) for approval.

Plans must include dimensions of the project, its location on the lot and materials and colors to be used. A letter explaining your plans is needed. See the Architectural Guide, available on the website, for more information.

The covenants give the AC up to 60 days to review plans; however, reviews are currently taking about two weeks from the time the AC receives useable plans. Decisions require a majority vote of the AC. Owners should not begin a project before

receiving written approval from the AC.

Please give your plans to Hamp at 613 Ashley Trail or email them to the address in the box.

In addition to AC approval, projects should comply with any applicable county ordinances and zoning regulations and may require county permits.

tic travel I was able to meet some of my neighbors and to become friends. I even went to the pool for the first time. There I met more neighbors and the more people I met the more I liked our neighborhood. This is a relatively safe and friendly place where you can walk your dog and say hello to the kids playing in the street. It seems like every kid in this neighborhood knows my dog's name. Our own little Mayberry.

But now it seems like every time I check my e-mail somebody has a problem with their neighbor. "I've had to call the police because this person did this and that person did that". I guess even Mayberry had their little neighborhood disputes. But with one major difference the people did not have email. When they had a problem with Floyd the barber they went to him and discussed the problem. E-mail allows us to express our thoughts while not putting ourselves out in the open for others to see. We can hit send and off goes another literary master piece blasting someone without their knowledge. It gives us all a little more courage and the ability to get our thoughts together while affording us the security of firing the first shot at who we consider to be the cause of all of our problems at the present time.
