

## By-Laws Amendments Approved

Two amendments dealing with scheduling the Annual Members Meeting and greater notification for all meetings were approved at a Special Members Meeting on March 5.

Amendment 1 changed Article III, Section 1 of the by-laws to allow the board of directors to schedule the annual members meeting at anytime during the month of April each year to avoid conflicts with other events. Previously,

the by-laws required the annual meeting to be on the first Thursday of April. This was a conflict with the Cherokee County Schools spring break, now scheduled during the first week of April.

Amendment 2 changed Article III Section 3 of the by-laws to require a 30-day notice of members meetings, both special and annual. Since Amendment 1 allows the annual meeting to vary

from year to year, a greater notice would be more appropriate to allow members to plan for attending the meetings.

## **Architectural Committee Update**

If you plan to add a structure including a fence, change the exterior of your home or lot, or the use of your lot, you must submit plans to the Architectural Committee (AC) for approval.

Plans must include dimensions of the project, its location on the lot and materials and colors to be used. A letter explaining your plans is needed. See the Architectural Guide, available on the website, for more information.

The covenants give the AC up to 60 days to review plans; however, reviews

are currently taking about two weeks from the time the AC receives useable plans. Decisions require a majority vote of the AC. Owners should not begin a project before receiving written approval from the AC.

Please give your plans to Hamp at 613 Ashley Trail or email them to the address in the box.

In addition to AC approval, projects should comply with any applicable county ordinances and zoning regulations and may require county permits.
