# No Swimming Pool This Summer?

The drought restrictions on outdoor water use have raised questions about the coming swim season.

Recent news articles indicate General Assembly interest in granting pool exemptions. Also a Georgia Environmental Protection Division recommendation about pools is due to be presented to the governor today.

Drought Level 3 rules allow filling pools to prevent structural damage, but the exception is not mentioned under the current Level 4.

A major resurfacing project is being planned for the WP pool before the upcoming season. This project requires that the pool be



completely drained. It is not clear if the pool could be refilled to swimming levels or just enough water added to avoid structural damage.

Pool Committee Chair Steve Dillon is working with the pool maintenance company to get answers.
