

# By-Laws Amendments

WPHA members will consider two amendments to the By-Laws at the annual meeting on April 17. Paper ballots will be distributed to members or proxies at the meeting. The text of the amendments follows.

#### Amendment 1

Purpose: Changes the requirement for the president to cosign all checks and allows single-signature checks to the electric, phone, water and pool maintenance companies. Other checks including reimbursements to individuals would still require two signatures.

Should Article VIII, Section 8(a) of the By-laws of Waverly Park Homeowners Assoc., Inc. be changed by deleting the phrase "all checks and promissory notes" and replacing it with "promissory notes and all checks except those paying bills from the electric, phone, water and pool maintenance companies."?

### Amendment 2

Purpose: Reduces the maximum number of directors from fifteen to five. Three to five directors may be elected if amendment passes.

Should Article IV, Section 1 of the By-laws of Waverly Park Homeowners Assoc., Inc. be changed by replacing "fifteen (15)" in the first sentence with "five (5)"?
