### **CCWSA Seeks Relaxed Watering Restrictions**

-From CCWSA and others

(May 23, 2008) The Cherokee County Water & Sewerage Authority (CCWSA) announced today that it has filed a pe-

tition with the Georgia Environmental Protection Division (EPD) requesting that CCWSA be allowed to move immediately to the Level IVc Modified Drought Response.



Level IVc Modified Drought Response allows outdoor water use on scheduled days between the hours of 12:00 midnight and 10:00 a.m. with odd num-

> bered addresses able to water on Tuesdays, Thursdays and Sundays, and even numbered addresses able to water on Mondays, Wednesdays and Saturdays.

According to the June 3

meeting agenda for the Cherokee County Board of Commissioners "Chairman Ahrens will give an update of the Cherokee County Water and Sewerage Authority's petition to the state to modify watering restrictions."

Ahrens also serves on the CCWSA Board of Directors.
