In addition to setting various property maintenance standards, residential parking restrictions for RVs, boats, trailers and ATVs are included.

annoying going on near you call 911 and report it. This will allow them to help keep us safe and nip problems in the bud.


#### Garage Sale

# ATV Ordinance Includes Go-karts, Golf Carts

The county's newly adopted ATV ordinance has provisions that prohibit the use of ATVs, golf cars and go-karts on public streets and rights-of-way, according to Cherokee County Marshal Ray Waters.
