Governor Perdue signed the Water Stewardship Act of 2010, on June 2.

The new law will bring changes to outdoor watering restrictions.

The Georgia Green Industry Assocation does offer their assessment of the new rules at:



Advance Voting

A voter who appears in person at a Satellite location (See Satellite Locations/Addresses below) during the advance voting period (Monday through Friday immediately preceding the date of the election) is not required to provide a reason why he or she is voting early.

Advance Voting will be conducted from 8:30 am to 7:00 pm the last full week before the election day to which the voting is applicable.

ATV Ordinance Includes Go-Karts, Golf Carts

The county's September 2008 ATV ordinance has provisions that prohibit the use of ATVs, golf carts and go-karts on public streets and rights-of-way, according to Cherokee County Marshal Ray Waters.
