Neighborhood Watch Update



Is Speeding Worth The Risk?

The distance from the **Waverly Park** entrance sign to the north end of Oxford Drive is only .7 mile. That's the most anyone must travel in or out of WP.

The table shows how little time you might save by exceeding the 25 MPH speed limit.

Compare that to speeding and:

- Hitting an old guy on a bike or a kid chasing a ball
- · Getting a ticket
- Going to court and jail
- · Being sued
- Getting a big insurance rate increase

Speeding is just not worth the risk.
