## Regular Monthly Meeting July 17, 2018

Meeting at Walters, 853 Oxford Drive. Called to order: 6:36 p.m.

Present at meeting:

- Others: Nick Lopitz, Neighborhood Watch
- 1. Noted that BOD Actions for Period Ending June 13, 2018, was approved by email.
- 2. Reviewed To Do List:
  - a. Discussed two bids for repainting pool house interior rooms.
    - i. Accepted (5-0-0) Rodriquez estimate for two restrooms only.
      - 1. To be scheduled pre-2019 swim season to avoid pool closure.
      - 2. Neutral colors.
- 3. Discussed updating WPHA insurance policy coverage to reflect pool house value, playground equipment, security cameras and WP entrance sign.
  - a. Pool house coverage increased to \$70,000,
  - b. Playground \$6,000,
  - c. Security cameras \$3,500.
- 4. Approved (5-0-0) \$613 increase to WPHA insurance annual premium for the increased coverages.
- 5. Discussed liens and other remedies for unpaid annual assessments.
- 6. Continued discussion of an initiation fee to be charged future new homeowners.
  - a. Amount of fee as a percentage of the annual assessment, probably 100%.
  - b. Earlier research indicates that other subdivisions of WP's age don't charge an initiation fee, and others that have started had to amend their covenants to allow the fee.
  - c. Jason to research.
